

Field Tour Announcement

Friday, July 29, 2005 8:30 a.m. Freshwater School 75 Greenwood Heights Drive Eureka, CA

On **July 29, 2005**, the North Coast Regional Water Quality Control Board (Regional Water Board) will tour portions of the Elk River and Freshwater Creek watersheds, near Eureka, California. The tour will involve viewing privately owned lands that are the subject of draft watershed-wide Waste Discharge Requirements that will be considered by the Regional Water Board at their meetings on September 14 and 27, 2005.

The public and agency representatives are invited to attend. The tour will be conducted by bus and will begin and end at the Freshwater School at 75 Greenwood Heights Drive, Eureka. The Regional Board will provide transportation for up to 50 people on a first-come, first-served basis.

Field trip participants should consider potential field conditions including uneven or muddy ground, poison oak, brush, ticks, adverse weather, and/or sun; and should wear appropriate footwear and dress accordingly.

It is anticipated that the tour will conclude and the bus will return to the starting point in Eureka at approximately 5:00 p.m.

Turn Right onto W Harris Street

W Harris Street becomes Hall Ave.

Turn Right onto Myrtle Ave.

Turn Right onto Freshwater-Kneeland Road

Turn Sharp Left onto Greenwood Heights Drive

End at 75 Greenwood Heights Drive 4 hrs, 13 minutes (distance 215 miles)

From the Arcata: Arcata to US-101 South 3.2 miles

Turn Sharp Left onto Greenwood Heights Drive <0.1 miles

End at 75 Greenwood Heights Drive
