1. Public Hearing to consider adoption of Proposed Order No. R1-2019-0021, Waste Discharge Requirements for Nonpoint Source Discharges and Other Controllable Water Quality Factors Related to Timber Harvesting and Associated Activities Conducted by Humboldt Redwood Company, LLC in the Upper Elk River Watershed, Humboldt County. Jim Burke, Senior Engineering Geologist, Southern Nonpoint Source & Forestry Unit, gave an overview and history of the Upper Elk River Watershed impairment and subsequent regulatory requirements that were implemented through a 2016 Waste Discharge Requirement (WDR) Order and an Action Plan for the Upper Elk River Sediment Total Maximum Daily Load (TMDL). On August 1, 2017, the State Water Board approved the TMDL Action Plan and via Resolution, directed the Regional Board to review and evaluate the WDR to ensure that it complied with all applicable TMDL requirements. Following discussions with Regional Water Board staff, Humboldt Redwood Company (HRC) proposed revisions to specific provisions of the 2016 WDR to implement TMDL hillslope targets and load allocation and on February 1, 2019, submitted the proposed revisions. Following a review of HRC's proposal and in consideration of the State Board's Resolution, the Regional Water Board developed the draft WDR Order R1-2019-0021, which incorporates the revised findings and specific requirements for riparian zone protection and wet weather restrictions designed to address and fully implement TMDL hillslope indicators, numeric targets and the load allocation. When the public comment period closed, the WDR was revised in response to public comments. Staff recommend approval of proposed WDR Order R1-2019-0021 incorporating a Change Sheet.

# Information Item

7. Update on implementation of Order No. R1-2015-0021, Waiver of Waste Discharge Requirements for Nonpoint Source Discharges Related to Certain Federal Land Management Activities on National Forest System Lands in the North Coast Region. Forest Fortescue, Engineering Geologist, Northern Nonpoint Source & Forestry Unit, gave a presentation, beginning with an overview of the Federal Waiver and its implementation to date, the number and types of projects enrolled, inspections conducted, general observations, and lessons learned. Mr. Fortescue's PowerPoint presentation highlighted the federal post-fire recovery and vegetation management projects, grazing allotment monitoring with sample results, and legacy sediment site treatment activities. Sam Flanagan, Geologist, Bureau of Land Management; John Exline, Director for the Pacific Southwest Region, U.S. Forest Service; Patty Grantham, Forest Supervisor, Klamath National Forest, U.S. Forest Service; and Ted McArthur, Forest Supervisor, Six Rivers National Forest, U.S. Forest Service, each gave a presentation that summarized their accomplishments, the progress toward TMDL implementation, and described their experiences and challenges implementing the Federal Waiver.
