Acting Board Chair, Vice-Chair John Corbett, called the Regional Water Board meeting to order at 8:30 a.m.

ii. Roll Call and Introductions

iv. Public Forum –

Vice Chair Corbett stated that the scope of this meeting of the North Coast Regional Water Quality Control Board would be limited by Temporary Restraining Orders (TROs) issued by the Humboldt Superior Court. Reading from the TROs, Mr. Corbett stated: the TROs restrain the Regional Water Board from taking any further action or holding any further hearings on Resolution Numbers R1-2005-0064, R1-2005-0065, R1-2005-0066 and R1-2005-0067; that the TROs provide notice that the court has set an Order to Show Cause hearing for October 5, 2005; that the TROs do not permit PALCO to harvest timber; and that the TROs will cause no negative impacts to the environment, nor will they violate any statutory deadlines.

Vice Chair Corbett stated that based on the TROs the Board would not be holding a hearing on the proposed watershed-wide waste discharge requirements, but that it would

hold the public forum. Corbett also, in consultation with legal counsel, admonished persons wishing to speak during the public forum that they may not discuss the substance of the WDRs or supporting evidence.
