10. **Executive Officer's Report**

Catherine Kuhlman pointed out the Dwinnell article in the Executive Officer's Report. She also briefed the board on:

A petition that was submitted to the State Board petitioning the Regional Water Board's WDRs monitoring program for Elk and Freshwater was dismissed by the State.

The City of Santa Rosa received a prestigious award from US EPA for their pretreatment program as a result of the North Coast Regional Water Board nomination. The award is only given to three or four Wastewater Treatment Plants in the country each year.

The MS4 Stormwater Permit scheduled for the January 2009 Board Meeting received extensive comments. Regional Water Board staff is going through the permit with the permittees in response to their request for clarification of the permit. As a result, the permit will be delayed by six months.
