1. Update on Water Quality Monitoring Results, Community Engagement, and Lily Bulb Order Development in the Smith River Plain (Ben Zabinsky, Brenna Sullivan, Chris Watt, and David Kuszmar)

David Kuszmar, Ben Zabinsky, Chris Watt, and Brenna Sullivan presented updates on water quality monitoring results, community engagement efforts, and

the development of the Lily Bulb Order in the Smith River Plain. The updates included detailed information on monitoring study results, community outreach activities, and the proposed regulatory framework for lily bulb cultivation to address water quality concerns.
