During the public workshops, Regional Water Board staff will provide a brief summary of the Regional Water Board's involvement in the review of timber harvest plans, its regulatory authority and mandates, and revisions to the current Non-Federal Timber Waiver. Members of the public and interested parties will be provided the opportunity to present oral and/or written comments.

Background

On June 23, 2004, the Regional Water Board adopted Order No. R1-2004-0016, "Categorical Waiver of Waste Discharge Requirements for Timber Harvest Activities on Non-Federal Lands". The Order, referred to as the (Timber Waiver), expires on June 23, 2009. The Regional Water Board intends to hold a hearing on June 4, 2004, to consider the adoption of an order that would revise the 2004 Non-Federal Timber waiver. The Waiver identifies five categories of timber harvest activities for which WDRs can be waived. Each category is described by eligibility criteria and contains general and specific criteria and conditions to ensure that impacts to water quality remain at less than significant levels.
