The North Coast Regional Water Quality Control Board (Regional Water Board) proposes to extend coverage under General Waste Discharge Requirements Order No. R1-2009-0105 (Order) for the Fiesta (LaBlue's) Cleaners, 580 Gravenstein Highway North, Sebastopol, California (site). The Regional Water Board adopted General Order No. R1-2009-0105 for the in-situ soil and groundwater remediation for volatile organic compound and/or metal impacted sites within the North Coast Region on December 10, 2009. The purpose of this notice is to inform interested parties, including owners of nearby land, of this proposed remediation and to invite public comment.

A release to the subsurface of solvents from dry cleaning operations has impacted soil and groundwater at the subject property. Soil vapor extraction has been conducted at the site to remediate shallow soils and groundwater. However, this system has not shown to be effective in remediating the deeper groundwater. Therefore, an additional remedial strategy is proposed which includes treating the deeper groundwater (from 35 to 80 feet below ground surface) in a limited area of the site. The planned remediation includes enhancing bioremediation by injecting an organic substrate, a dechlorinating bacterial culture, and zero valent iron (ZVI). The ZVI is a natural compound with anti-methanogenic bacteria properties to reduce methane generation.
