14.4-Acre South Face Slope Area
Central Disposal Site, Sonoma County, California**

Ladies and Gentlemen:

SCS Engineers is submitting the above-referenced report on behalf of the Sonoma County Department of Transportation and Public Works (County) and Keller Canyon Landfill Inc.

The County proposes to implement partial final closure over approximately 14.4 acres (plan area) within the South Slope of Landfill 1 at the Central Disposal Site. The 14.4-Acre South Face Slope Area has been filled to final grades and no further waste placement is proposed for that area. The attached report describes proposed partial final closure and post-closure maintenance provisions for this area, and has been prepared in accordance with applicable requirements of Title 27 of the California Code of Regulations. The design criteria are consistent with your agency's conditions of approval for the previously-proposed final closure plan for the Central Disposal Site (GeoSyntec Consultants, 2008).

The proposed partial final closure measures for the 14.4-acre area compliment County plans for re-permitting full disposal operations at the Central Disposal Site. Specifically, the County proposes to construct new composite-lined waste cells within the currently-permitted refuse disposal boundary areas, resume municipal solid waste filling operations in accordance with all applicable regulatory and permit conditions including the daily tonnage limits specified in the existing Solid Waste Facility Permit, and make minor changes to the water quality monitoring program regulated under the existing Waste Discharge Requirements (WDRs). Under separate cover, an application for revised WDRs and an Amended Joint Technical Document describing these proposed activities have been submitted to your agency for approval.




The proposed partial final closure capital improvement project for the 14.4-Acre South Face Slope Area will be undertaken concurrent with construction of the first new waste cell as proposed in the JTD, subject to all agency approvals.


With this submittal we seek your agency's approval of the Partial Final Closure and Post-Closure Maintenance Plan for the 14.4-Acre South Face Slope Area.
