## **State Water Board to Host Free Funding Fair on Infrastructure Projects in San Diego**

**SACRAMENTO** -- The State Water Resources Control Board, along with five partner agencies, will host a free California Financing Coordinating Committee (CFCC) Funding Fair Thursday, April 2, in San Diego.

The CFCC Funding Fair is an excellent opportunity for public works and local government representatives to obtain information on funding currently available for infrastructure projects. Project categories include, but are not limited to: drinking water; wastewater; solid waste; water quality; water supply; water conservation; energy efficiency; flood management; community facilities; streets and highways and emergency response vehicles.

The fair will be held at the San Diego Regional Water Quality Control Board, 2375 Northside Drive, Suite 100, San Diego.

The CFCC was formed in 1998 and is made up of six funding members: The State Water Board; California Department of Water Resources; California Department of Housing and Community Development; U.S. Department of Agriculture Rural Development; U.S. Department of the Interior Bureau of Reclamation and the California Infrastructure and Economic Development Bank.

CFCC members facilitate and expedite the completion of various types of infrastructure projects by helping customers combine the resources of different agencies. Since 2000, CFCC members have conducted free funding fairs statewide to educate the public about available financial and technical resources.

These funding fairs provide one-stop shopping for those looking for infrastructure funding in California. Each of the listed agencies will provide information on their available infrastructure grant, loan and bond financing programs, including funding available from the Water Quality, Supply, and Infrastructure Improvement Act of 2014 (Proposition 1).
