Drinking water advisory group welcomes nine appointees

SACRAMENTO – The State Water Resources Control Board announced today nine appointments and two re-appointments to the <u>Safe and Affordable Funding for Equity and Resilience (SAFER) Advisory Group</u>, which provides input on the <u>Safe and Affordable Drinking Water Fund</u>'s annual spending priorities to ensure they reflect the needs and perspectives of California communities. The recent <u>appointments</u> round out the 11 continuing members who will serve until December 2024.

The <u>Advisory Group</u> comprises members with diverse drinking water backgrounds and experiences, including representatives of public water systems, local agencies, tribes, nongovernmental organizations and residents served by domestic wells or water systems in disadvantaged communities. The group meets quarterly to provide feedback on key SAFER plans and proposals.

"We have learned and accomplished a great deal during the first years of the Safe and Affordable Funding for Equity and Resilience program, and this is in no small part due to the insight and experience with drinking water issues that past and continuing Advisory Group members have shared with us. Their input is critical to helping us ensure our funding priorities respond to the changing needs of communities and water systems," said Board Chair Joaquin Esquivel. "I thank the new appointees for their commitment to partnering on these issues. We are grateful for their collaboration, which ensures the board's financial assistance is as effective as possible in helping communities and water systems achieve safe drinking water."

In 2019, California enacted Senate Bill 200, establishing the Safe and Affordable Drinking Water Fund (SADW) to strengthen access to safe and affordable drinking water and advance the Human Right to Water. The same year, the board launched the SAFER drinking water program to administer the SADW Fund and several complementary funding sources. Together with the board's regulatory authorities, data, analysis and other tools, the SAFER program uses this funding to improve access to safe and affordable drinking water for all Californians, especially those in disadvantaged communities. The board adopts and publishes a Fund Expenditure Plan annually to

outline goals for the SADW fund; the plan is developed in consultation with advisory group members.
