NOTICE OF AVAILABILTY FOR PUBLIC COMMENT AND NOTICE OF PUBLIC MEETING ON AN AMENDMENT TO THE WATER QUALITY CONTROL PLAN FOR THE LAHONTAN BASIN TO CLARIFY MOJAVE RIVER BENEFICIAL USE DESIGNATIONS, UPDATE SITE CLEANUP, LAND DISPOSAL AND BISHOP UNDERGROUND TANK POLICY SECTIONS, AND OTHER EDITORIAL REVISIONS

NOTICE IS HEREBY GIVEN THAT the State Water Resources Control Board (State Water Board) is seeking written public comments on the Lahontan Regional Water Quality Control Board's (Lahontan Water Board) final amendment to the Water Quality Control Plan for the Lahontan Basin (Basin Plan) to Clarify Mojave River Beneficial Use Designations, Update Site Cleanup, Land Disposal and Bishop Underground Tank Policy Sections and Other Editorial Revisions.

BACKGROUND

The Lahontan Water Board adopted the Basin Plan amendment on June 8, 2022 by Resolution No. R6T-2022-0021. The Basin Plan amendment includes revisions to clarify the beneficial use designations for the Mojave River and correct errors in Chapter 2 (Present and Potential Beneficial Uses), inserts language in Chapter 3 (Water Quality Objectives) to describe the statewide mercury water quality objectives, updates language in Chapter 4 (Implementation) related to Site Cleanup, Land Disposal and Underground Storage Tanks, and in Chapter 6 (Plans and Policies) related to State Water Board Plans and Policies.

Some elements in the amendment involve actions that have already been analyzed under the California Environmental Quality Act (CEQA) and no new information triggers the need for supplemental or subsequent CEQA analysis. Other elements involve revising the structure, syntax, cross-reference, grammar, or punctuation in the Basin Plan. Therefore, the amendment does not have the potential for resulting in either a direct physical change in the environment, or a reasonably foreseeable indirect physical change in the environment. Consequently, no additional CEQA documentation required for certified regulatory programs is needed for this basin planning action. (Cal. Code Regs., tit. 23, §3720, subds. (b), (c)(2).)

REQUIREMENTS FOR SUBMITTING COMMENTS

In accordance with California Code of Regulations, title 23, section 3779, subdivision (f), the State Water Board may refuse to accept any comment that does not satisfy all of the following requirements:

- Comments must specifically address the final version of the Basin Plan amendment adopted by the Regional Water Board
- If the Regional Water Board previously responded to a similar or identical comment, the commenter must explain why and in what manner the commenter believes each of the responses provided by the Regional Water Board to each comment was inadequate or incorrect.
- 3. The commenter also must include either a statement that each of the comments was timely raised before the Regional Water Board, or an explanation of why the commenter was unable to raise the specific comment before the Regional Water Board.

NOTICE IS FURTHER HEREBY GIVEN THAT the State Water Board will consider adopting a resolution to approve the Basin Plan amendment.
