# **Draft Expedited Drinking Water Grant Funding Program Guidelines**

#### **BACKGROUND**

Division of Financial Assistance (DFA) staff are proposing to implement the Draft Guidelines to provide an expedited process by which public agency applicants with qualifying high priority projects can receive State grant funding. The Expedited Drinking Water Grant funding program will utilize a variety of state funding sources for drinking water infrastructure projects, including but not limited to: Proposition 1, Proposition 68, the Safe and Affordable Drinking Water Fund, and the Budget Act of 2021.

Application forms, reviews, procedures, and requirements may vary from the DWSRF funding program to support the reduction of processing times and information submittal requirements. By establishing this program, critical drinking water infrastructure projects will be constructed on a shorter timeline, resulting in many small communities gaining access to safe, clean, affordable, and accessible water much sooner than would occur without this program.
