## NOTICE OF OPPORTUNITY TO COMMENT

PROPOSED APPROVAL OF AMENDMENT TO THE WATER QUALITY CONTROL PLAN FOR THE SANTA ANA REGION TO REVISE THE WATER QUALITY OBJECTIVE FOR NITRATE-NITROGEN IN THE CHINO SOUTH GROUNDWATER MANAGEMENT ZONE

NOTICE IS HEREBY GIVEN THAT the State Water Resources Control Board (State Water Board) will accept comments on the proposed approval of the Santa Ana Regional Water Quality Control Board's (Santa Ana Water Board) amendment to the Water Quality Control Plan for the Santa Ana River Basin that would revise the water quality objective for nitrate-nitrogen in the Chino South Groundwater Management Zone for the Santa Ana Region (Basin Plan amendment). **REQUIREMENTS FOR SUBMITTING COMMENTS** (23 Cal. Code Regs., § 3779, subd. (f)). The State Water Board may refuse to accept any comments that do not satisfy all of the following requirements:

- 1. Comments must specifically address the final version of the Basin Plan amendment adopted by the Santa Ana Water Board.
- If the Santa Ana Water Board previously responded to a similar or identical comment, the commenter must explain why and in what manner the commenter believes each of the responses provided by the Santa Ana Water Board to each comment was inadequate or incorrect.
- 3. The commenter also must include either a statement that each of the comments was timely raised before the Santa Ana Water Board, or an explanation of why the commenter was unable to raise the specific comment before the Santa Ana Water Board.
