BOARD MEMBER COMMUNICATION

Dan Odenweller reported that he had attended Salinity Task Force meetings with Dr. Longley, the Irrigated Lands Program Technical Issues Committee meeting on 23 October, and the CalFed Science Conference this week.

Kate Hart reported having lunch with David Guy of NCWA and discussing the mercury TMDL, and attended the Yosemite Law Conference at Tenaya Lodge which included a presentation on pharmaceuticals in wastewater.

Dr. Longley attended the Salinity Task Force meetings, met with Assembly staffers regarding salt, spoke with the Sacramento Bee regarding salt, and spoke with the Fresno Bee regarding E. Coli.

Al Brizard attended a drainage consortium meeting regarding studies on the San Joaquin River Dissolved Oxygen problems.

Chairman Schneider will attend the Water Quality Coordinating Committee meeting next Monday and Tuesday and hopes all Board members can attend, particularly the environmental justice session which he helped coordinate.

EXECUTIVE OFFICER'S REPORT

Al Brizard asked if the Hilmar Cheese (Item 10) public outreach plan review was complete. Ms. Creedon reported that the plan was complete and finalized, and was posted on the Regional Board web site.

Mr. Brizard asked for an update on French Bar (Item 47). Ms. Creedon stated that engineering funding had been received. Jack Del Conte reported that the developer has started erosion control work, and that staff is working with the District Attorney in case the developer does not satisfactorily complete the corrective action.

Chairman Schneider asked about follow-up on environmental justice issues from a previous Board meeting. Ms. Creedon reported that she and Loren Harlow had met with local interest groups to discuss their issues. Dr. Longley reported that he has a meeting scheduled with the interested parties next month, and that funding for infrastructure improvements is a major problem.

PUBLIC FORUM

Warren Tellefson, Central Valley Clean Water Association, presented information to the Board on the laws concerning water softeners.

NPDES PERMITS

University of California (UC), UC Davis Center for Aquatic Biology and Aquaculture, Yolo and Solano Counties – *Consideration of NPDES Permit Renewal*

A public hearing was held. Diana Messina and Dave Carlson presented the staff report. Steve Giles, Tony Garvin, David Philips and Joseph Ceha gave additional testimony.

This item was continued to a future Board Meeting to consider Salinity limits and monitoring.

A public hearing was held. Douglas Wachtell presented the staff report. Brett L. Cooper and Loren Harlow provided additional testimony

MOTION: By Dr. Longley seconded by Mr. Cabaldon to approve the Cleanup and Abatement Order. Unanimously approved.

City of Livingston, Industrial Wastewater Treatment Facility – *Consideration of Cease and Desist Order*

Board member, Mr. Al Brizard recused himself from this item.

A public hearing was held. Joanne Kipps presented the staff report. Bert Van Voris, Loren Harlow, Stephen Onstot, Bill Jennings and Jim Bernotte presented additional testimony.

MOTION: By Ms. Mulholland seconded by Dr. Longley to approve the Cease and Desist Order. Approved with a vote of 6-0-1. Mr. Odenweller abstained.

Delta Long Term Management Strategy for Dredged Material in the Delta (LTMS)

Sue McConnell presented the staff report. Mr. Bill Jennings and Roberta Gulad also spoke on this subject. The Board agreed that the Chair should sign the draft LTMS charter.

BOARD MEMBER COMMUNICATION

Dr. Longley reported the following meetings:

- On 26 September, met with Steve Macaulay (CUWA), Jerry Meral (National Wildlife Federation), and Steve Boccadoro (Dairy CARES) of the Salinity Committee regarding the 30 November salinity-planning meeting.
- On 28 September, Salinity Planning briefings were provided to Dan Nelson (San Luis-Delta Mendota Water Authority), Steve Chidester (San Joaquin River Exchange Contractors), and Alan Short and Walter Ward (Modesto Irrigation District).
- On 2 October, met with Anthony Barkett (Stockton attorney) and John Herrick (South Delta Water Agency), DeeAnne Gillick (Neumiller, and Beardslee), Karna Herrigfeld (Herum, Crabtree and Brown).
- On 5 October, met with Mike Lynch and Holly King at the Great Valley Water Center.
- On October 11 Fresno Channel 47 regarding significance of E. Coli outbreak (not speaking as a Board member).
- On 15 October, met with County of Fresno.
- On 25 October, met with Gail Delihant, legislative director with Assemblyman Aghazarian, Heather Halsey (principle consultant for the Senate committee on safety and toxic materials), the principle consultant for the Assembly Parks and Wildlife Committee, the principle consultant for Assemblyman George Plescia, Bill Craven Water Committee Principal Consultant.

- 23 October gave statement to Tom Phillips, Sacramento Bee Reporter.
- On 26 October, met with Bill Jennings (CSPA).

Dr. Longley also reported that the final contract for salinity studies has been approved. A subcontract is being worked on for public education and outreach. Work is well underway on getting the Central Valley salinity group going. Two organizations are envisioned: a Salt Commission to conduct studies, and a 501(c)(6) Coalition. Staff is working on a salinity strategy under existing policy to be presented shortly.

Dan Odenweller reported having dinner with Bill Jennings and discussing obtaining depositions. The topic had previously been cleared with Counsel.

Soapy Mulholland said that she meets regularly with the Department of Fish and Wildlife regarding Land Trust issues, and not Regional Board issues.

EXECUTIVE OFFICER'S REPORT

The Executive Officer noted that information on the Hilmar Cheese Supplemental Environmental Project can be found at HilmarSEP.com, which will be linked to the Board's web site.

Musco Olives (Item 30). Frances McChesney noted that this is a pending matter before the Board, so discussion may have to be limited. Al Brizard asked about the current status of the facility. Ms. Creedon reported that the project has been transferred to Sacramento. Sacramento staff are currently reviewing the case, have inspected the site, and will be developing recommendations for future actions. Chairman Schneider said that the Board should work with the Department of Food and Agriculture on the Musco case.

Stanislaus Farm Supply (Item 21). Al Brizard asked what the "pilot project" was. Amy Terrell explained that groundwater is polluted from an ammonia tank leak and that procedures are being developed whereby groundwater can be extracted and used for crop irrigation. Crops would take up nitrogen from the pumped groundwater.

Irrigated Lands Report. Al Brizard asked for an update on membership lists received from the Coalitions. Kelly Briggs reported that lists had been received from all eight Coalitions. Three lists were complete. Five lists had some data gaps that we are trying to have filled before annual fee billings are mailed next month. Some Coalitions report that they are not turning in some names until December, which is a violation of the waiver – we need full lists. Legal Counsel is writing an opinion on the requirement to submit complete membership lists. Regarding NOVs for failure to submit Section 13267 Orders, the Executive Officer's Report said that there were 106 failures to respond to the NOVs, but that number has declined to 75.

Chairman Schneider noted much discussion in newspapers on E. Coli and the ag community's efforts on the issue. Bill Croyle reported that the Delta Coalition was working on DNA/RNA typing of E. Coli to identify the source of the E. Coli, and preliminary results would be available in about two weeks.

Kate Hart commented that all parties needed to work together and hold a healthy debate on the mercury issues in the Region.

Richard Price and Rick Black updated the Board on the Pilot Program. Mark Rentz, Jeff Pylon and Bill Croyle also spoke. This was for the Board's information. No action was taken.
