**Workshop on Renewal of Conditional Waivers
for Discharges from Irrigated Lands**

On 11 July 2003, the Central Valley Regional Water Quality Control Board (Central Valley Water Board) adopted Resolution No. R5-2003-0105, *Conditional Waivers of Waste Discharge Requirements for Discharges From Irrigated Lands Within the Central Valley Region* (Conditional Waivers) pursuant to Water Code Section 13269 for discharges from irrigated lands to surface waters. The Conditional Waivers expire on 31 December 2005, and the Central Valley Water Board staff sent out tentative renewal documents for public comment on 4 October 2005.

Staff will present a workshop on the Conditional Waiver Order Renewal Package for information only. The Central Valley Water Board will not take any action on this item.
