DISCHARGES FROM IRRIGATED LANDS

On 11 July 2003, the Central Valley Regional Water Quality Control Board (Central Valley Water Board) adopted Resolution No. R5-2003-0105, *Conditional Waivers of Waste Discharge Requirements for Discharges From Irrigated Lands Within the Central Valley Region* (Conditional Waivers) pursuant to Water Code Section 13269 for discharges from irrigated lands to surface waters. Resolution No. R5-2003-0105 expires on 30 June 2006.

The Central Valley Water Board will consider adopting two new Conditional Waiver Orders to take effect on 1 July 2006. Both Orders contain two attachments. Attachment A in both Orders is *Applicable Water Quality Control Plans, Definitions, and Information Sheet* and Attachment B in both Orders is *Terms and Conditions*.
