Dear Mr Wyels:

James G. Sweeney and Amelia M. Sweeney submit their response in opposition to the purported "activation" of the Petition of Asociacon de Gente Unida por el Agua and Environmental Law Foundation regarding Waste Discharge Requirements General Order No. R5-2013-0122 for Existing Milk Cow Dairies (General Order). This Petition is designated by your office as "SWRCB/OCC File A-2283(b)" and will be referred to as the "Petition."

The Petition is time barred, and should be dismissed. The General Order was adopted on October 3, 2013. Under Water Code § 13320, the last day to file the Petition was Monday, November 4, 2013, as the thirtieth day after October 3, 2013 was November 2, 2013–a Saturday. The Petition is dated November 5, 2013 so even if filed on that day it was filed a day late. Therefore, the Petition should be dismissed for violation of Water Code § 13320 as being time barred.

The General Order was adopted without due process. The Notice about the Tentative General Order was first posted on the Regional Board's website on or about August 9, 2013 at an obscure, difficult-to-find location. One would have to stumble through numerous web pages to stumble across the Notice and the Tentative General Order and its Attachments.

No written notice regarding the proposed General Order was mailed to the Sweeneys or other dairy owners and operators. The only reason the Sweeneys learned of the proposed General Order, and the 30-day comment period ending September 9, 2013, was because one of the Regional Board staff members called these events to the Sweeney's attention on August 12, 2013.

The Regional Board has a list of mailing addresses and email addresses for the dairy owners subject to their jurisdiction. Prior to adoption of the 2007 General Order, the Regional Board notified dairy owners and operators by registered mail of the proposed Order and its pending adoption. But in the case of the 2013 General Order, no attempt was made to give actual notice to the dairy owners/operators intended to be regulated. Thus, under the holding of Mullane v. Central Hanover Bank & Trust Company (339 U.S. 306 (1950)), the Regional Board denied due process to all dairymen and dairy organizations when it failed to give notice of the comment period and of the date of the proposed adoption of the General Order by a method "reasonably calculated" to inform them of the proceedings.
