SUBJECT: Penalty Enforcement Actions and Priorities for This Year - Fiscal Year 2011/2012

**Summary Report** 

DISCUSSION: This item provides a summary of penalty enforcement actions for fiscal year (FY) 2011/12, including the issuance and/or settlement of administrative civil liability (ACL) complaints. We also call attention to our public outreach efforts for enforcement cases and describe our enforcement program priorities for the current year.

> The Executive Officer approved penalties totaling \$983,753 in 44 of the 50 active enforcement cases involving penalty assessments during FY 2011/12. These actions addressed a variety of violations including violations of NPDES permit effluent limits, violations of stormwater (industrial, construction, and municipal) NPDES permit requirements, violations of pollution cleanup requirements, and unauthorized discharges of sediment-laden water and chlorinated water. The penalties assessed were based on the State Water Board's Enforcement Policy and are shown in Appendix A's Tables A1 through A5:

## **Table A1 – Previous ACL Cases Resolved in FY 2011/12**

At the start of FY 2011/12, there were six unresolved ACL cases with proposed penalties totaling \$690,909. Four of the cases were resolved and ACL orders issued based on settlement agreements with the dischargers. Final penalties totaled \$184,300. The two remaining cases are pending resolution as noted in Table A5.

#### Table A2 – ACL Cases Initiated and Resolved in FY 2011/12

We pursued three ACL complaints totaling \$540,507 in proposed penalties. The cases were resolved and ACL orders issued based on settlement agreements with the dischargers. Final penalties totaled \$529,453.

## Table A3 – FY 2011/12 Penalties Assessed for Late Reports

We issued conditional offers to settle with dischargers who did not submit required industrial stormwater permit annual reports on time. Seventeen dischargers accepted the offers and agreed to pay the associated penalties, which totaled \$27,000. See the related discussion below.

#### **Table A4 – FY 2011/12 Mandatory Minimum Penalties Assessed**

We issued conditional offers to settle NPDES permit effluent limit violations at the mandatory minimum level of \$3,000 per violation. Twenty dischargers accepted the offers and agreed to pay the associated penalties, which totaled \$243,000.

#### Table A5 – ACLs Cases in Settlement Discussion

As of the end of FY 2011/2012 on June 30, 2012, the Board's prosecution team was engaged in settlement discussions with dischargers for six ACL cases with proposed penalties totaling \$672,068. Since then, two of these cases have had ACL orders issued based on settlement agreements with the dischargers, totaling \$521,526.

We notify the regulated community and the public about pending enforcement actions as an integral part of our enforcement program. In addition to providing documents to interested parties by mail and email, anyone can obtain information about our enforcement cases by doing the following:

- subscribing to an <u>email list</u> for enforcement items;
- checking the current status of enforcement cases and accessing documents on our website; and
- following <u>press releases</u> issued on significant proposed actions through the State Water Board's Office of Public Affairs.

Additional enforcement-related information is also available via the State Water Board and San Francisco Estuary Partnership websites. The State Water Board <u>enforcement page</u> provides access to enforcement reports and the <u>Enforcement Policy</u>. Supplemental environmental projects are occasionally approved as part of settlement penalty actions. The San Francisco Estuary Partnership provides a list of current and completed projects on its <u>website</u> with the status of pending projects and links to associated documents.

Our enforcement priorities for FY 2012/13 will continue to focus first on the most egregious violations with the highest water quality impacts, followed by prosecution of violations that threaten the integrity of the Board's requirements. These include discharges that result in fish kills or other acute aquatic impacts; large or frequent sanitary sewer overflows; NPDES permit violations subject to mandatory minimum penalties; illegal fill of wetlands and violations of permitted wetland fill requirements; violations of site cleanup requirements; and violations of construction, industrial, and municipal stormwater permits. Regarding the latter, since we have observed improved compliance with industrial stormwater permit annual report requirements, we will focus enforcement efforts towards industrial facilities that discharge stormwater without a permit and facilities that are not implementing effective pollution prevention actions.

We anticipate expanding use of settlement offers in situations where a number of dischargers have violated the same requirement and the penalties would be relatively low. Compared to issuance of individual complaints, this approach is proving to be an efficient way to send the broader message to the regulated community about the ramifications of noncompliance and the importance of staying in compliance. Details of this approach and its successes will be provided in a future report to the Board.
