# **Site Cleanup Requirements**

Item 5 – Updated Site Cleanup Requirements and Rescission of Order Nos. 95-235, 97-124, and 97-125 for the Former Point Molate Naval Fuel Depot, Richmond, Contra Costa County – Adoption of Site Cleanup Requirements

Water Board Staff Terry Seward (on behalf of George Leyva) made the presentation to the Board and gave an overview of the cleanup activities and the proposed Order.

Mr. Wolfe noted that for this item staff had separated functions and that he would be advising the Board and Assistant Executive Officer Dyan Whyte was leading the Prosecution Team.

Water Board Staff Barbara Sieminski made a presentation to the Board on behalf of the Prosecution Team. She described the Site, gave an overview of the tentative order, and summarized comments received.

Julie Macedo, Prosecution Team Counsel, summarized legal issues pertaining to naming dischargers to the order.

Linda Beresford, representing counsel to Scott Monroe, addressed the Board and expressed support for the Prosecution Team's recommendation to not name Scott Monroe.

Loretta James, representing Golden Gate Way, LLC, and the Peacocks, stated for the record that the Peacocks did not have knowledge of a discharge until late 2008 at the earliest.
