Waste Discharge Requirements and Rescission of Order No. R2-2002-

0008, Santa Clara All-Purpose Landfill, Santa Clara County

Dear Ms. Shikada and Mr. Eimer:

The California Regional Water Quality Control Board, San Francisco Bay Region (Board), is updating the waste discharge requirements for the closed Santa Clara All-Purpose Class III municipal refuse disposal site (Landfill) located between San Tomas Aquino Creek and the Guadalupe River, north of W. Tasman Drive and south of Highway 237, in Santa Clara. The purpose of this update, as specified in the attached tentative order, is to reflect the proposed development on the Landfill and to ensure that the change in land use approved by the City and the LEA can be implemented in a way that protects water quality, human health, and the environment.

The deadline for receipt of comment on the tentative order is 5:00 p.m. on April 17, 2017. Comments must be sent to the attention of Cleet Carlton. Persons wishing to file written comments on or objections to the tentative order or other aspects of this matter must do so no later than this deadline so that such comments may be considered by the Board.

The Board will consider the tentative order during a meeting to commence at 9:00 a.m. on May 10, 2017, in the Auditorium of the Elihu Harris Building at 1515 Clay Street in Oakland. Interested persons are invited to attend and express their views at the public hearing.

Pursuant to California Code of Regulations, Title 23 section 2050(c), any party that challenges the Board's action on this matter through a petition to the State Water Resources Control Board under Water Code section 13320 will be limited to raising only

those substantive issues or objections that were raised before the Board at the public hearing or in timely submitted written correspondence.
