Dear Mr. Carson:

Enclosed is Order No. R2-2018-1006, which imposes an administrative civil liability in the amount of **\$72,500** to the District for discharges to waters of the United States in violation of NPDES permit effluent limits. The District is required to pay **\$36,250** of the total liability by **August 3, 2018**.

In addition, the District shall complete the supplemental environmental project (SEP) as set forth in the Order.

As part of implementation of the SEP, quarterly progress and a final completion report are required. The first quarterly progress report is due July 5, 2018, and certification of SEP completion is due no later than June 5, 2019. Please send these reports to the contacts shown below:

Payment

The payment shall be remitted by check in the amount of **\$36,250** to the “State Water Pollution Cleanup and Abatement Account” as set forth in the Order. We will endeavor to send an invoice for payment in advance of the payment due date. However, any failure by us to send an invoice does not absolve the District of its obligation to comply with the Order or provide payment by the above due date.

If the payment deadline set forth herein is not met, the Board’s prosecution staff may allow a 15-day period to cure any non-payment. Following the 15th day of non-payment, prosecution staff may enforce the terms of the Order and seek the immediate payment of the remaining balance. Alternatively, the Board’s Assistant Executive Officer may refer the matter to the California Attorney General’s Office to obtain payment in compliance with the terms of the Order or take other appropriate actions.
