## NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT AND HEARING ON

## GONSALVES & SANTUCCI, INC., DRAFT WASTE DISCHARGE REQUIREMENTS ORDER FOR THE DISCHARGE OF FILL TO WETLANDS FOR THE CONCO INDUSTRIAL SUBDIVISION PROJECT

**NOTICE IS HEREBY GIVEN THAT** the San Francisco Bay Regional Water Quality Control Board (Water Board) will accept written comments, as provided below, on the draft waste discharge requirements (draft WDRs Order) for Gonsalves & Santucci, Inc. (Discharger), Conco Industrial Subdivision Project (Project).

The draft WDRs Order includes requirements related to the Project's discharges into waters of the state and authorizes the fill of wetlands for the Project, located on 66.57 acres of vacant industrial-zoned land situated along the western boundary of the Walnut Creek channel approximately 0.74 miles south of the Waterfront Road bridge crossing (latitude 38.018344, longitude -122.076297). The U.S. Army Corps of Engineers (Corps) claims no jurisdiction over any wetlands that will be impacted by the Project. Therefore, fill of seasonal wetlands does not require authorization pursuant to a Clean Water Act section 404 permit. The discharge of fill to waters of the State is regulated under California Water Code section 13263.

The Project encompasses the construction of six industrial lots along with internal roads and utilities. Once completed it will provide five lots dedicated to contractor yard uses and one centrally located hub. The majority of the development site consists of uplands, with vegetation dominated by non-native grasses. The site also contains 9.8 acres of seasonal and tidal wetlands. Approximately 1.40 acres of seasonal wetlands will be permanently impacted through direct filling with clean fill as part of the industrial lot construction. Mitigation for the permanent loss of seasonal wetlands will be provided through the onsite creation of 2.8 acres of seasonal and tidal wetlands.
