NOTICE OF OPPORTUNITY TO COMMENT ON GENERAL AMENDMENT TO WASTE DISCHARGE REQUIREMENTS FOR

LONG-TERM FLOOD PROTECTION CONSIDERATIONS AT 16 CLOSED AND OPERATING MUNICIPAL SOLID WASTE BAYFRONT LANDFILLS

NOTICE IS HEREBY GIVEN THAT the San Francisco Bay Regional Water Quality Control Board (Water Board) will accept written comments on the Tentative Order (Order) for Amending Waste Discharge Requirements (WDR) Orders for 16 Bayfront landfills.

The Regional Water Board has reviewed the existing WDRs for the 16 closed and operating landfills around the San Francisco Bay, and finds that it is appropriate to revise them through this Order to address potential effects of sea level rise, and other related site-specific vulnerabilities such as groundwater rise due to their Bayfront locations. The Order requires submission of a Long-Term Flood Protection Plan, which shall be updated every five years to consider the best available science at the time.
