Dear Mr. Rabin,

Complaint No. R2-2024-1032 (Complaint) enclosed with this letter issues an administrative civil liability (ACL) against SODA LLC (Discharger) in the amount of \$2,910.00. This liability is for Discharger's alleged violation of the Stormwater Enforcement Act of 1998 (Water Code sections 13399.25 and 13399.43).

The Discharger can respond to the Complaint by appearing before the Executive Officer of the Regional Water Board at a public hearing to contest the matter or by signing the enclosed Waiver Form to waive the hearing requirement and pay the civil liability in full.

1. The Complaint can be contested at the following meeting:

If the Discharger intends to present arguments about its ability to pay, it must provide reliable financial documentation to establish that ability or inability. Contact the Water Board staff listed below for more information about the documentation that needs to be provided, in advance of the hearing, to support a claim of financial difficulty.

If the Regional Water Board issues an order requiring payment, the Discharger may challenge that order by filing a petition for review with the State Water Board pursuant to CWC Section 13320. 2. The public hearing scheduled above can be waived if Discharger agrees to pay the liability as proposed in the Complaint. To pursue this option, the Waiver must be **signed**, **dated**, **and received by**
