REVISED NOTICE OF INTENT TO ADOPT A SUBSEQUENT NEGATIVE DECLARATION AND NOTICE OF PUBLIC HEARING TO ADOPT

CONDITIONAL WAIVER OF WASTE DISCHARGE REQUIREMENTS FOR GRAZING OPERATIONS IN THE NORTH SAN FRANCISCO BAY REGION (NAPA RIVER, SONOMA CREEK, PETALUMA RIVER, AND TOMALES BAY WATERSHEDS, AND ALL GRAZING OPERATIONS IN POINT REYES NATIONAL SEASHORE)

NOTICE IS HEREBY GIVEN that the San Francisco Bay Regional Water Quality Control Board (Water Board) will hold a public hearing on July 9, 2025, ~~May 14, 2025~~, to consider adoption of a Conditional Waiver of Waste Discharge Requirements for Grazing Operations (Grazing Waiver) in accordance with this revised notice.

The Water Board currently regulates about 88,000 acres of grazing lands in the Tomales Bay, Sonoma Creek, and Napa River watersheds with two separate Grazing Waivers. A revised multi-watershed Grazing Waiver is proposed to renew the existing waivers and to expand the scope of coverage to include the Petaluma River watershed and grazing operations in Point Reyes National Seashore that do not drain to Tomales Bay. Requirements for Grazing Waiver compliance will largely remain the same.

The Water Board circulated project documents for public review and comment, including a proposed Initial Study/Subsequent Negative Declaration prepared in accordance with the California Environmental Quality Act (CEQA; Public Resources Code §21000 et seq.). The proposed Initial Study/Subsequent Negative Declaration summarizes the Grazing Waiver requirements and identifies no significant environmental impacts from the proposed Grazing Waiver. The Water Board, acting as the Lead Agency under CEQA, must adopt the Subsequent Negative Declaration before adopting the Grazing Waiver.

At the conclusion of the hearing, the Board will consider adoption of the proposed Initial Study/Subsequent Negative Declaration and the proposed Grazing Waiver, including changes that are consistent with the general purpose of the proposed Grazing Waiver and are a logical outgrowth of the comments received.
