LAND DISPOSAL PROGRAM: HEARING NOTICE, DRAFT PROPOSED REVISED WASTE DISCHARGE REQUIREMENTS FOR CHICAGO GRADE CLASS III LANDFILL, ATASCADERO, CALIFORNIA

Central Coast Regional Water Quality Control Board (Water Board) staff prepared the draft revised Waste Discharge Requirements Order No. R3-2009-0001, draft Monitoring and Reporting Program No. R3-2009-0001, and draft Staff Report for the Chicago Grade Class III Landfill. The Water Board will hear public comments and consider this matter at its February 6, 2009 Board meeting in San Luis Obispo.

Interested parties not able to access the documents electronically may request to receive a hard copy delivered by mail. Interested parties must submit comments on the subject document no later than **December 15, 2008**. The Water Board will not accept comments or other written submissions on the draft Order after December 15, 2008, unless the Water Board Chairman rules that exclusion would create a severe hardship, and that the late submission will not prejudice any party or the Water Board. Any person submitting late comments must explain why the materials were not submitted by December 15, 2008. The Water Board Chairman will rule on late submittals at or before the hearing. Late submissions that consist of evidence (as opposed to policy statements or comments) are generally prejudicial unless all designated parties and Water Board staff have time to consider the evidence before the meeting.
