**NOTICE OF PUBLIC HEARING
NOTICE OF FILING A DRAFT ENVIRONMENTAL DOCUMENT**

To Consider Amending the Water Quality Control Plan for the Central Coast Basin to (1) De-designate the Shellfish Harvesting Beneficial Use for San Lorenzo River Estuary, (2) Modify San Lorenzo River Subbasin and Aptos-Soquel Subbasin Prohibition, and (3) Adopt the Total Maximum Daily Loads for Pathogens In San Lorenzo River Estuary, San Lorenzo River, Branciforte Creek, Camp Evers Creek, Carbonera Creek, and Lompico Creek

NOTICE IS HEREBY GIVEN that the California Regional Water Quality Control Board Central Coast Region (Central Coast Water Board) will hold a public hearing to consider adoption of a resolution amending the Water Quality Control Plan (Basin Plan) of the Central Coast Region. If accepted, the resolution will incorporate into the Basin Plan (1) the removal of the shellfish harvesting beneficial use in San Lorenzo River Estuary, (2) a modification of the San Lorenzo River Subbasin and Aptos-Soquel Subbasin Prohibition, and (3) Total Maximum Daily Loads for Pathogens in **San Lorenzo River Estuary, San Lorenzo River, Branciforte Creek, Camp Evers Creek, Carbonera Creek, and Lompico Creek**. At the conclusion of the hearing the Central Coast Water Board will consider approval of the proposed resolution. The Basin Plan establishes measures to protect beneficial uses of water and achieve water quality objectives.

Actions to amend the Basin Plan by the Central Coast Water Board will be taken in accordance with a regulatory program exempt under section 21080.5 of the Public Resources Code from the requirement to prepare an environmental impact report under the California Environmental Quality Act (Public Resources Code, section 21000 et seq.) and with other applicable laws and regulations.

The Central Coast Water Board is proposing to remove the shellfish harvesting beneficial use from the San Lorenzo River Estuary; the shellfish harvesting beneficial is not an appropriate beneficial use designation for San Lorenzo River Estuary.

Secondly, the Central Coast Water Board is proposing to modify the San Lorenzo River Subbasin and Aptos-Soquel Subbasin waste discharge prohibition. Modification of the prohibition is required to address nonpoint source discharges from various nonpoint sources of fecal indicator bacteria, including discharges from domesticated animals and humans. Controlling nonpoint source discharges through prohibitions is consistent with State Water Resources Control Board's *Policy for Implementation and Enforcement of the Nonpoint Source Pollution Control Program*, May 20, 2004.

Thirdly, the Central Coast Water Board is proposing to adopt Total Maximum Daily Loads (TMDL) for pathogens in San Lorenzo River Estuary, San Lorenzo River, Branciforte Creek, Camp Evers Creek, Carbonera Creek, and Lompico Creek. The purpose of the TMDL is to protect the surface waters from water quality degradation. The TMDL protects beneficial uses from discharges associated with fecal coliform concentration exceeding water quality objectives.
