The Central Coast Water Board (Water Board) will hold a public hearing to consider amending the Basin Plan to establish Total Maximum Daily Loads (TMDLs) and other actions for the Lower Salinas River Watershed as described below:

AGENDA ITEM NO. 18: CONSIDERATION TO ADOPT BASIN PLAN AMENDMENTS BY THE WATER BOARD

The Water Board will consider adoption of Resolution No. R3-2010-0017 at the September 2, 2010 Water Board meeting, amending the Basin Plan to:

- (1) ADOPT TOTAL MAXIMUM DAILY LOADS FOR FECAL COLIFORM IN LOWER SALINAS RIVER WATERSHED,
- (2) ADD THE LOWER SALINAS RIVER WATERSHED TO THE DOMESTIC ANIMAL WASTE DISCHARGE PROHIBITION; AND
- (3) ADD THE LOWER SALINAS RIVER WATERSHED TO THE HUMAN FECAL MATERIAL DISCHARGE PROHIBITION

NOTE: The Water Board considered Resolution No. R3-2010-0017 at the March 18, 2010 Water Board meeting. The Water Board deferred their decision on the Resolution to a later date; the Water Board will now consider adoption of the Resolution at the September 2, 2010 meeting. A 45-day public comment period for the Resolution preceded the March 18, 2010 meeting; the chair of the Water Board closed the public comment period for Resolution R3-2010-0017 at the March 18, 2010 hearing. The public will have an opportunity to provide oral comment at the September 2, 2010 Water Board meeting. Water Board staff has made no substantive changes to Resolution No. R3-2010-0017 or supporting documents compared to those considered by the Water Board on March 18, 2010. Non-substantive changes made to the amendment and supporting documents are summarized in Attachment-7 to the Staff Report.
