## NOTICE OF PUBLIC HEARING

## To Consider Adoption of Total Maximum Daily Loads for Chlorpyrifos and Diazinon in the Lower Salinas River Watershed

The California Regional Water Quality Control Board Central Coast Region (Central Coast Water Board) will hold a public hearing to consider approval of a resolution to adopt Total Maximum Daily Loads (TMDLs) for Chlorpyrifos and Diazinon in the Lower Salinas River Watershed (Resolution R3-2011-0005).

The purpose of the TMDLs is to protect waters within the Lower Salinas River Watershed from water quality degradation due to elevated levels of chlorpyrifos and diazinon. The resolution proposes numeric targets to protect beneficial uses, assigns allocations to achieve the numeric targets, and outlines an implementation and monitoring plan to gauge the success of achieving the TMDLs. Components of the TMDLs are written in the Final Project Report.

Persons wishing to comment on the proposed resolution to adopt TMDLs for Chlorpyrifos and Diazinon in the Lower Salinas River Watershed must submit comments in writing to the Central Coast Water Board at its office in San Luis Obispo no later than **March 18, 2011**. Late comments will not be accepted into the record unless approved by the Chair.
