**DISCUSSION**

**Violations Listing**

Staff uses the California Integrated Water Quality System (CIWQS) to track Water Board data, including violations and enforcement actions. Attachment 1 is a CIWQS list of violations by dischargers between November 1, 2012, and November 31, 2012. CIWQS has a sewer system overflow (SSO) module that provides tracking and reporting of such spills.

Significant or Notable Violations

- Lucas and Lewellen Vineyards, Inc., Buellton, Santa Barbara County. County and DFG staff reported winery waste discharges to storm drain and Zaca Creek in fall 2012. The facility is not authorized to discharge waste to waters of the state or of the U.S. Water Board staff has sent two notices of violation including requirements to cease discharging to surface waters and to apply for coverage under the general industrial stormwater permit.
- Ventana Inn, Big Sur, Monterey County. The discharger detected seepage of wastewater along the edge of the Coast Ridge Road downslope from the newly installed Mule Ridge subsurface disposal area, which occurred from 11/26/2012 through 11/29/2012. Staff has classified this as a Class 2 violation; however, staff will keep an eye on this facility because they have had similar violations in the past.
