RESOLUTION NO. R3-2014-0051

TERMINATION OF LOS OSOS INDIVIDUAL ENFORCEMENT ORDERS

The California Regional Water Quality Control Board, Central Coast Region (hereafter “Water Board”) finds that:

1. The Water Board took enforcement actions against individual dischargers in the Los Osos/Baywood Park prohibition zone in the form of cease and desist orders and cleanup and abatement orders in 2006 and 2007. The orders require the recipients to hook up to a community wastewater collection and treatment system when it becomes available.
2. San Luis Obispo County has planned, designed, financed, and begun construction of the community wastewater collection and treatment system. The County expects to complete the system in 2016 and order recipients will be required to hook up to the system at that time.
3. The individual enforcement orders are no long necessary.

THEREFORE, the Water Board hereby resolves that:
