Subject: Re: Amended Demand for Payment

The 30 days allowed for payment to me of the \$25,000.00 I spent to be compliant with CDO #1002 has passed with no response from you (CCRWQCB).

That's disappointing.

Now, I hear you (CCRWQCB) will systematically rescind all the remaining CDO's at your meeting later in September.

Here's how I see it:

I received Draft CDO #1002 after it was signed for by someone not living here.

It demanded I provide personal information within 5 days or fines of \$1,000.00 a day would start.

It was signed by Roger W Briggs.

No one has the Authority to demand this, nor to threaten fines for non-compliance.

It also demanded I should pump my septic EVERY 2 months. Now, you (CCRWQCB) finally admit you have no Authority to demand septic pumping every 3 YEARS.

CDO #1002 arrived after "hearings" where I was found "guilty" because I live here (and, presumably, use my septic system "in violation of the Basin Plan/83-13")

If I didn't comply, (by not putting even 1 drop of clean water into my septic) I'd be fined \$5,000.00 a day..(over \$35 MILLION now)

It was signed by Gerhard Hubner "for Roger W Briggs"

I was able to be compliant.

No one cared and I've been ignored for 7 years because you (CCRWQCB/Harvey Packard) continued to tell me, "you're compliant as long as the County works on the sewer".

I believe you (CCRWQCB) don't have much Authority at all.
I believe it's all been Bullying/Extortion to get this sewer in, although, in my opinion, it won't ever work and there's no way to force us to stop using our septics on our Private Property and/or hook up & use the sewer.
I've said repeatedly, ad nauseum, that I can't afford to hook up, (\$5-12K) nor the \$hundreds a month to use it.
But, no one cares about that, me or any of my Rights that are long gone, thanks to you (CCRWQCB) and your pals at SLO County.
I haven't given up on somebody wanting to help, even though it's Local, County, State and Federal Governments against me.

This is a Demand for Payment by Miss Cinthea T Coleman, property owner, senior, single for \$25,000.00 from the Central Coast Regional Water Control Board.

Eight years ago, I was given Cease and Desist Order #1002 by CCRWQCB Board of Directors for using the septic system on the property I own at 1399 14th Street, Baywood Park and for this Reason only.

It threatened fines of "\$5,000.00 a day" for every day I continued to use said septic in violation of "83-13", "the Basin Plan" and/or "the Basin Prohibition""Moratorium".

To date, this totals around \$35 Million.

Thus

,

I had two choices:
Stop using the septic system or be fined.
A third choice of compliance was

later

offered "as long as the county works on the sewer" but this was not a viable choice because:

1. I have no control over the county regarding sewer work.
2. This sewer project has been ongoing for some 30 years and is not now finished.
3. Until the project is actually in operation, then and only then can the septic systems be in compliance.

I chose to comply with CDO #1002 by implementing my "System for Compliance".

It cost \$25,000.00 and allows me to not only eliminate the use of the septic but the need for hooking up to a sewer as well

All plans, receipts and results were submitted with no response or support of any kind

.
I was able to be "compliant" with the Cease and Desist Order 7 years ago.

To force me to comply by ANY other method is unacceptable and, quite possibly, illegal.

In accordance with the Law, you (CCRWQCB) have 30 days to comply with me, for a Change, and remit \$25,000.00.
