Regional Funding Priorities

- Disadvantaged Communities (DACs)
 - Drinking water and wastewater
- Regional monitoring
 - Domestic well sampling (public health)
 - Sustainability (SGMA and climate change)
 - Evaluate basin/watershed health

- Human Right to Water Law (CWC 106.3)
 - State and Regional Board resolutions
- Sustainable Groundwater Management Act
- California Water Action Plan

Management Structure

- Third party administrator/trustee
 - The Bay Foundation of Morro Bay
 - Meets state/federal auditing requirements
- Financial stability
 - Endowments provide project continuity
- Pre-approved GAP-SEP
 - 2012 GAP workplan & resolution
 - 2015 Board direction

- Disadvantaged Communities
 - 2 projects north and south
 - 1 pending regional (Item 17)
- Regional Monitoring
 - 2 domestic well sampling projects
 - 1 basin assessment project
 - 1 hybrid project Civic Spark fellows
 - 1 pending SGMA Paso Basin GSP

Pre-approved third partyadministered SEP Benefits

- Provide regional benefit
 - Focused on priorities
- Decrease administrative burden
 - Limits project review
 - Limits project implementation oversight
 - Liability waived upon payment

Revised SEP Policy

(Effective May 3, 2018)

- Human right to water, environmental justice & climate change
- State Board approval of
 - Regional monitoring SEPs
 - Third party administrators
- Transparency & accountability
 - Project posting
 - Annual reporting to Office of Enforcement

Next Steps

- Formalize R3 pre-approved SEPs
 - via State Board Resolution to approve:
 - third party-administrator
 - project types and associated criteria
- Post available SEPs
- Annual performance updates
 - Implementation reporting
 - Affirm and adjust project priorities
