TERMINATION OF LOS OSOS INDIVIDUAL WASTE DISCHARGE REQUIREMENTS, ENFORCEMENT ORDERS, AND ENROLLMENTS IN GENERAL WASTE DISCHARGE REQUIREMENTS ORDER NO. 00-12

The California Regional Water Quality Control Board, Central Coast Region (hereafter Central Coast Water Board) finds that:

- The Central Coast Water Board adopted waste discharge requirements, enforcement orders, and enrollments into General Waste Discharge Requirements for Residential On-Site Wastewater Systems within the Bayview Heights and Martin Tract Areas of Los Osos, Order No. 00-12 (General Order 00-12) applying to individual dischargers in the Los Osos/Baywood Park prohibition zone beginning in 1983. The orders require the dischargers to connect to a community wastewater collection and treatment system when it becomes available, with the exception of the general order enrollees.
- 2. San Luis Obispo County has completed construction of the Los Osos community municipal wastewater collection and treatment system.
- 3. The individual WDRs, enforcement orders, and two enrollments in General Order No. 00-12 are no longer necessary.
