Funding and Resources for DACs

- Funding for Long Term Solutions:
 - Clean Water State Revolving Fund (CWSRF)
 - Drinking Water State Revolving Fund (DWSRF)
- Technical Assistance
- Interim/Emergency Funding:
 - Household Drinking Water and Wastewater Needs
 - Drinking Water for Schools
 - Cleanup and Abatement Account

CWSRF and DWSRF (and Propositions 1 and 68)

- Provide low interest loans (planning/construction)
 - DWSRF: For eligible public water systems, for distribution lines, tanks, treatment facilities, consolidation projects, etc.
 - CWSRF: For eligible publicly-owned treatment works, for sewer lines, treatment facilities, consolidations projects, etc.
- For eligible small* DACs, via the SRF application process:
 - Principal forgiveness, and Proposition 1 or 68 grants
 - Proposition 1 (2014) funds fully committed soon
 - Proposition 68 (2018) \$250 million for drinking water
- * Generally limited to systems serving less than 10,000 people for drinking water, and less than 20,000 people for wastewater

Technical Assistance (TA)

- One page TA Request Form, for all TA resources
 - https://www.waterboards.ca.gov/water_issues/programs/grants_loa ns/proposition1/tech_asst_funding.html
- Available for both drinking water and wastewater needs
- Typical types of TA offered:
 - Board/operator training
 - Rate studies
 - Income surveys
 - Technical Managerial Financial capacity evaluations
 - Funding applications
 - Outreach

Household Drinking Water and Wastewater Needs

- Household Well Replacement
 - To date, \$10 million awarded to three nonprofits
 - Funds distributed to individual households or small water systems (<15 connections) with dry wells
 - Connection to nearby system if possible, otherwise well replacement
- 18/19 budget includes \$10 million for household needs
 - Well replacement, septic system replacement, connection to public systems, or point-of-use treatment, etc.
 - Division of Financial Assistance evaluating needs and best approach to administering the funds

Drinking Water for Schools (DWFS)

- In 2016, \$9.5 million allocated from General Fund
- Grants for public schools/districts serving DACs
- Not only for water quality needs, also for adequate access
- Eligible project types (maximum \$100,000 per school):
 - Water bottle filling stations or drinking fountains
 - Point-of-entry/point-of-use treatment
 - Replace or repair fixtures to address lead
 - Bottled/hauled water
- This solicitation closes March 1, 2019
- 18/19 budget includes additional \$6.8 million for DWFS

Cleanup & Abatement Account (CAA)

- New CAA Funding Program Guidelines adopted by the State Water Board in December 2018
- CAA grants for urgent drinking water needs (for DACs)
- Typically to address contamination, or inadequate supply for basic demands (e.g., failed well)
- Typical project types
 - Bottled or hauled water
 - Point-of-Use (POU) treatment
 - Well repair, rehabilitation, replacement
 - Emergency interties

UCLA Pilot Project (Salinas Valley)

- Originally funded in 2015 (\$2 million from CAA)
- In 2018, State Water Board increased award to \$2.5 million
- New approach to address nitrate for small/rural systems
- Treatment via remotely-managed reverse osmosis
- UCLA will evaluate cost effectiveness of remotely managing a cluster of systems (pilot includes 3 systems)
- Central Coast Water Board staff issued monitoring and reporting programs to UCLA in August 2017, related to the discharge of residual waste from the treatment systems
