
Community Identification

Needs Assessment



Community Characteristics – Median Household Income, population, other indicators; involvement with local IRWM governance



Drinking Water – source(s) of water; estimated number of wells; water treatment; accessibility and affordability; system issues



Wastewater – system information; insufficient system issues



Stormwater/ urban runoff/ flood management – identify issues



Water System Financing – rate structure; system financing needs



Other - drinking water, wastewater, stormwater regulatory/compliance issues

- Well testing; septic system training (Pajaro)
- Water leadership courses (Greater Monterey)
