A total of 3,748 comment letters were submitted, including three late submittals. Of these, 3,578 letters were submitted as identical form letters (in support of the draft order). The following is a list of individuals who submitted public comments on Draft Ag Order 4.0, not including the list of the 3,578 individuals who submitted a form letter. A list of the 3,578 individuals that submitted the form letter is provided on the public comment letter ftp site identified in the staff report. Note that some commenters provided multiple comment letters; in most cases these individuals represent more than one operation and submitted a comment letter for each operation they represent.
