This entire case and its prosecution, the basis for the prosecution and the hearing board is basically an adulterated and overwhelming case of the most prejudicial proceedings I have had an opportunity to observe in my three quarter of a century of existence, it is an abuse of power, reminiscent of the days of Lords and despotic kings, wherein you had charges with no basis of proof, (our septic tanks are polluting the basin) leveled against you brought before a tribunal or some other source of archaic proceedings, not allowed to subpoena witnesses: Shirley Bianchi, Jerry Gregory, Pandora N. 
