TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—8500 SUNSET BOULEVARD (WH) OWNER, LLC—SUNSET LA CINIEGA PROJECT, 8500-8544 SUNSET BOULEVARD, WEST HOLLYWOOD, CALIFORNIA (NPDES NO. CAG994004, CI—10026)

Dear Mr. Kuba:

In our letter dated February 7, 2014, we informed you that the subject discharge is regulated under Order No. R4-2013-0095, *General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements for Groundwater Discharges from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on June 6, 2013.

We have reviewed your January 9, 2015, letter which requested termination of your coverage under the General NPDES Permit. The letter indicated that construction project was completed and the permit is no longer needed.

Staff has inspected the facility and verified that there is no discharge to the storm drain. Since there is no discharge of groundwater from the project site, coverage under Board Order No. R4-2013-0095, General NPDES Permit No. CAG994004, CI-10026 for the facility is hereby terminated except for enforcement purposes.

Please note that if future discharges of groundwater to surface water becomes necessary, you must file a Report of Waste Discharge with this office and obtain Waste Discharge Requirements (WDRs) prior to discharging any groundwater from the site to surface waters.
