**TERMINATION OF COVERAGE UNDER STATEWIDE GENERAL WASTE DISCHARGE REQUIREMENTS, DEEP WELL EXTRACTION AND INJECTION TESTING - ANHEUSER-BUSCH, LOS ANGELES BREWERY, 15800 ROSCOE BOULEVARD, VAN NUYS, CALIFORNIA (FILE NO. 09-032, ORDER NO. 2012-0010-DWQ, SERIES NO. 003, CI NO. 10197, GLOBAL ID WDR100000237)**

Dear Mr. Gutierrez:

On December 16, 2015, this Regional Water Quality Control Board (Regional Board) informed you that the subject discharge is regulated under State Water Resource Control Board (State Board) Order No. 2012-0010-DWQ, which specifies your Waste Discharge Requirements (WDR).

In a February 4, 2019 letter you requested termination of WDR coverage under State Board Order No. 2012-0010-DWQ. The termination is requested because long-term injection of treated brewery wastewater is no longer being considered, and extraction and injection testing is no longer planned. The letter indicated that deep monitoring well A/B MW-1 and injection well A/B IW-1, at 8100 Woolsey Avenue, in Van Nuys, California will be abandoned in compliance with Los Angeles County and State of California regulations. **The coverage under State Board Order No. 2012-0010-DWQ for the subject site is no longer needed and hereby terminated except for enforcement purposes to address non-compliance, if any, during the term of permit coverage.**
