**TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT AND WASTE DISCHARGE REQUIREMENT- CALABASAS VILLAGE LP, AVANTI BUILDING 8, 23500 PARK SORRENTO, CALABASAS, CALIFORNIA (NPDES NO. CAG994004, CI-10301)**

Dear Mr. Bianchi:

The subject discharges are regulated under Order No. R4-2013-0095, *General National Pollutant Discharge Elimination System and Waste Discharge Requirements for Discharges of Groundwater from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on June 6, 2013.

We have reviewed your November 13, 2017, letter which requested termination of your coverage under the General NPDES Permit. The letter indicated that groundwater discharges stopped at the site on August 31, 2017 and that the General NPDES permit is no longer needed. Since there is no discharge of groundwater from the project site, coverage under Board Order R4-2013-0095, General NPDES Permit No. CAG994004, CI-10301 is hereby terminated except for enforcement purposes.

Please note that if future discharges of groundwater to surface waters or land become necessary, you must file a Report of Waste Discharge with this Board and obtain appropriate waste discharge requirements.
