**WASTE DISCHARGE REQUIREMENTS AND TIME SCHEDULE ORDER – EQUILON ENTERPRISES, LLC, MORMON ISLAND MARINE TERMINAL FACILITY, WILMINGTON, CA, NPDES NO. CA0003557, CI-1596**

Our letters dated March 23 and May 4, 2006, transmitted the tentative and revised tentative Orders for renewal of your permit to discharge wastes under the National Pollutant Discharge Elimination System (NPDES). In addition, the letter also included a Time Schedule Order (TSO) for Equilon Enterprises, LLC to come into compliance with the discharge limitations contained in the Waste Discharge Requirements (WDRs) and NPDES permit.

Pursuant to Division 7 of the California Water Code, this Regional Board at a public hearing held on May 11, 2006, reviewed the tentative requirements, considered all factors in the case, and adopted Order No. R4-2006-0047, and TSO No. R4-2006-0048 (copies attached) relative to the waste discharge and TSO, respectively. Order No. R4-2006-0047 serves as your permit under the NPDES and expires on April 10, 2011. Section 13376 of the California Water Code requires that an application for a new permit must be filed at least 180 days before the expiration date. TSO No. R4-2006-0048 will be in effect until May 11, 2011. All other provisions of Order No. R4-2006-0047, not in conflict with TSO No. R4-2006-0048, are in full force and effect.

You are required to implement the *Monitoring and Reporting Program* (MRP) on the effective date of Order No. R4-2006-0047 (May 11, 2006). Your first monitoring report for the May – June reporting period is due by July 15, 2006. All monitoring reports should be sent to the Regional Board, Attn: Information Technology Unit.

When submitting monitoring, technical reports, or any correspondence regarding the discharge under Order No. R4-2006-0047, and TSO under Order No. R4-2006-0048 to the Regional Board, please include a reference to *Compliance File No. CI-1596 and NPDES No. CA0003557 which* will assure that the reports are directed to the appropriate file and staff. Please do not combine your discharge monitoring reports with other reports. Submit each type of report as a separate document.
