TYPOGRAPHICAL CORRECTION FOR WASTE DISCHARGE REQUIREMENTS (WDRs) AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT FOR THE CITY OF OXNARD, OXNARD WASTEWATER TREATMENT PLANT (ORDER NO. R4-2018-0140, NPDES NO. CA0054097, CI NO. 2022)

Dear Mr. Thien,

On October 30, 2018, the Regional Water Quality Control Board, Los Angeles Region (Regional Water Board) staff transmitted Order No. R4-2018-0140, which was adopted on October 11, 2018 and serves as Waste Discharge Requirements (WDRs) and National Pollutant Discharge Elimination System (NPDES) permit for the City of Oxnard's Oxnard Wastewater Treatment Plant. The Monitoring and Reporting Program of the Order in Table E-11 specifies monitoring periods and reporting schedules for all required monitoring under the Order. The Self-Monitoring Report (SMR) due for the semiannual monitoring is stated as May 15 for the period from January 1 to June 30, and November 15 for the period from July 1 to December 31. The Table also set the due date for annual monitoring report as August 15 for the period from January 1 through December 31. These reporting dates for semiannual monitoring occur during the monitoring periods; the annual monitoring due date should be April 15 to be consistent with other NPDES permittees. The Regional Water Board has determined that these were typographical errors.

Therefore, the Regional Water Board has modified Order No. R4-2018-0140, adopted by this Board on October 11, 2018, to correct these minor typographical errors pursuant to 40 CFR section 122.63.

Table E-11 of the MRP shall read as follows:

Weekly	Sunday following Permit effective date or on Permit effective date if on a Sunday	Sunday through Saturday	Submit with monthly SMR
Monthly	First day of calendar month following Permit effective date or on Permit effective date if that date is first day of the month	1 st day of calendar month through last day of calendar month	Submit with monthly SMR
Quarterly	Closest of January 1, April 1, July 1, or October 1 following (or on) Permit effective date	January 1 to March 31 April 1 to June 30 July 1 to September 30 October 1 to December 31	By the 15th day of the second month after the month of sampling
Semiannually	Closest of January 1 or July 1 following (or on) Permit effective date	January 1 to June 30 July 1 to December 31	May <u>August 15</u> November <u>February 15</u>
Annually	January 1 following (or on) Permit effective date	January 1 through December 31	August <u>April 15</u>
