REGIONAL BOARD ORDER NO. R4-2006-0080 GROUNDWATER MONITORING WORKPLAN – SAVAGE CANYON LANDFILL, WHITTIER, CA (FILE NO. 63-082)

Dear Mr. Pelsler:

On October 24, 2006, the Los Angeles Regional Water Quality Control Board (Regional Board) adopted Order No. R4-2006-0080, which revised waste discharge requirements (WDRs) for the Savage Canyon Landfill (Landfill), owned and operated by the City of Whittier (City). The principal reason for revising the WDRs was to accommodate revisions to the monitoring and reporting program, including an updated groundwater monitoring network. On May 18, 2009, the City submitted a workplan for an alternative monitoring program proposing to screen for soil gas in existing landfill gas monitoring probes as a surrogate to groundwater monitoring downgradient of the Landfill. The workplan was approved and the Landfill monitoring and reporting program (M&RP) CI-4469 was revised on July 23, 2009. On April 6, 2010 City staff submitted corrections to the landfill gas monitoring probe schedule included in Table 1 of the M&RP CI-4469. The M&RP is being revised to include the correct gas monitoring probes that are part of the Landfill monitoring program.


