TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM AND WASTE DISCHARGE REQUIREMENTS—PRISM HOSPITALITY, LP, HUMNIT HOTEL AT LAX LLC, 6225 W. CENTURY BOULEVARD, LOS ANGELES, CALIFORNIA (NPDES NO. CAG994003, CI-4581)

The subject discharge is regulated under Order No. Order No. R4-2009-0047, General National Pollutant Discharge Elimination System and Waste Discharge Requirements for Discharges of Nonprocess Wastewater to Surface Waters in Coastal Watersheds in Los Angeles and Ventura Counties, adopted by this Board on April 2, 2009.

We have reviewed your March 26, 2015, letter which requested termination of your coverage under the General NPDES Permit. The letter indicated that you obtained an industrial discharge permit from City of Los Angeles to discharge nonprocess wastewater from your facility to sanitary sewer system and general NPDES permit is no longer needed. You ceased wastewater discharges to the storm drain system on January 8, 2015. On September 8, 2015, Board staff inspected the project site and verified that there is no discharge of nonprocess wastewater from the project site to the storm drain system. Since there is no discharge of wastewater from the site to storm drain, coverage under Board Order R4-2009-0047, General NPDES Permit No. CAG994003, CI-4581 for the facility is hereby terminated except for enforcement purposes.

Please note that if future discharges of groundwater to surface waters or land become necessary, you must file a Report of Waste Discharge with this Board and obtain appropriate waste discharge requirements.
