WASTE DISCHARGE REQUIREMENTS
FOR
CITY OF THOUSAND OAKS
(Hill Canyon Wastewater Treatment Plant)

The California Regional Water Quality Control Board (RWQCB), Los Angeles Region (Regional Board), finds:

- 1. The City of Thousand Oaks discharges municipal and industrial wastewater from the Hill Canyon Wastewater Treatment Plant (HCWTP), a tertiary wastewater treatment plant located at 9600 Santa Rosa Road, Camarillo, under waste discharge requirements contained in Order No. 96-044 (NPDES No. CA0056294), adopted by this Regional Board on June 10, 1996. This Order serves as a permit under the National Pollutant Discharge Elimination System (NPDES No. CA0056294).
- 2. On February 18, 1997, the Discharger requested that we modify language in their NPDES permit to reflect the definition of filtered wastewater as it reads in Title 22, Division 4, Chapter 3, Article 1, Section 60301 (r).
- 3. This revision of waste discharge requirements for this discharge is exempt from the provisions of Chapter 3 (commencing with Section 21100) of Division 13 of the Public Resources Code (California Environmental Quality Act) in accordance with Water Code Section 13389.

The Regional Board has notified the discharger and interested agencies and persons of its intent to amend waste discharge requirements for this discharge and has provided them with an opportunity to submit their written views and recommendations.

The Regional Board, in a public hearing, heard and considered all comments pertaining to the tentative revised requirements.

This Order shall serve as a National Pollutant Discharge Elimination System permit pursuant to Section 402 of the Federal Clean Water Act or amendments thereto, and shall take effect at the end of ten days from the date of its adoption, provided the Regional Administrator, USEPA, has no objections.

IT IS HEREBY ORDERED that Order No. 96-044, adopted by this Board on June 10, 1996, is hereby amended as follows:

1. Discharge Limitation number 6, on page 11 of Order No. 96-044, shall read as follows:

The wastes discharged to courses shall have received treatment equivalent to that of filtered wastewater. Filtered wastewater means oxidized and coagulated wastewater which has been passes through natural undisturbed soils or filter media, such as sand or diatomacious earth, so that the turbidity of the filtered wastewater does not exceed (a) an average operating turbidity of 2 Nephelometric turbidity units (NTU's), (b) and does not exceed 5 NTU's more than 5 percent of the time (72 minutes) during any 24 hour period.

2. The Expiration date, and all other Limitations, Requirements, and Provisions of Order No. 96-044 are unchanged and shall remain in full force and effect.

REVISED WASTE DISCHARGE REQUIREMENTS - CITY OF THOUSAND OAKS. HILL CANYON WASTEWATER TREATMENT PLANT (NPDES Permit No. CA0056294, CI No. 4917)

Our letter dated March 28, 1997, transmitted tentative revised Waste Discharge Requirements for your discharge of treated municipal and industrial wastewater into the North and South Forks of Arroyo Conejo.

Also, please do not combine other reports with your monitoring reports. Submit each type of report as a separate document.
