ADOPTED WASTE DISCHARGE REQUIREMENTS (WDRS) AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT AND RESPONSE TO COMMENTS – SANTA CLARITA VALLEY SANITATION DISTRICT, VALENCIA WATER RECLAMATION PLANT (VALENCIA WRP), SANTA CLARITA, CA (NPDES PERMIT NO. CA0054216, CI-4993)

Our letter dated May 2, 2022, transmitted the revised tentative WDRs and NPDES Permit for the Valencia WRP.

In accordance with administrative procedures, the Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) at a public hearing held on May 12, 2022, reviewed the revised tentative requirements, considered all the factors in the case, and adopted WDRs and NPDES Order No. **R4-2022-0174**, with the correction in the change sheet, and with revisions to the compliance schedule that occurred as a logical outgrowth of discussion that took place during the hearing.
