## ADMINISTRATIVE ADDITION TO PRETREATMENT PROGRAM FOR WASTE DISCHARGE REQUIREMENTS AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMITS – COUNTY SANITATION DISTRICTS OF LOS ANGELES COUNTY:

- Pomona Water Reclamation Plant (NPDES NO. CA0053619, CI-0755)
- San Jose Creek Water Reclamation Plant (NPDES NO. CA0053911, CI-5542)
- Whittier Narrows Water Reclamation Plant (NPDES NO. CA0053716, CI-2848)
- Saugus Water Reclamation Plant (NPDES NO. CA0053619, CI-2960)
- Valencia Water Reclamation Plant (NPDES NO. CA0053911, CI-4993)

A required citation to the Code of Federal Regulations, title 40, section 122.44 (40 CFR 122.44) has inadvertently been left out of recently adopted permits. To correct this error, we are making the following changes to the permits for the aforementioned facilities (language added / language removed):
