**RESCISSION OF WASTE DISCHARGE REQUIREMENTS AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT FOR EDGINGTON OIL COMPANY (NPDES NO. CA0057363, CI NO. 6181, ORDER NO. 98-095), LOCATED AT 2400 EAST ARTESIA BLVD., LONG BEACH, CALIFORNIA**
