**WASTE DISCHARGE REQUIREMENTS AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT / TIME SCHEDULE ORDER – LOS ANGELES DEPARTMENT OF WATER AND POWER (LADWP), HAYNES GENERATING STATION TANK FARMS: TANK FARMS A,B,C, & D; E; F&G; H&J, 6801 EAST SECOND STREET, LONG BEACH, CALIFORNIA (NPDES NO. CA0057649, CI NO. 6208)**

Dear Ms. Damron:

Our letter dated May 5, 2006, transmitted the revised tentative Order for renewal of your permit to discharge wastes under the National Pollutant Discharge Elimination System (NPDES). In addition, the letter also included a Time Schedule Order (TSO) for LADWP to come into compliance with the discharge limitations contained in the Waste Discharge Requirements (WDRs) and NPDES permit.

Pursuant to Division 7 of the California Water Code, this Regional Board at a public hearing held on June 8, 2006, reviewed the tentative requirements, considered all factors in the case, and adopted Order No. R4-2006-0054, and TSO No. R4-2006-0055 (copies attached) relative to the waste discharge and TSO, respectively. Order No. R4-2006-0054 serves as your permit under the NPDES and expires on May 10, 2011. Section 13376 of the California Water Code requires that an application for a new permit must be filed at least 180 days before the expiration date. TSO No. R4-2006-0055 will be in effect until May 17, 2010. All other provisions of Order No. R4-2006-0054, not in conflict with TSO No. R4-2006-0055, are in full force and effect.

You are required to implement the *Monitoring and Reporting Program* (MRP) on the effective date of Order No. R4-2006-0054 (July 8, 2006). Your first monitoring report for the July – September reporting period is due by November 1, 2006. All monitoring reports should be sent to the Regional Board, Attn: Information Technology Unit.

When submitting monitoring, technical reports, or any correspondence regarding the discharge under Order No. R4-2006-0054, and TSO under Order No. R4-2006-0055 to the Regional Board, please include a reference to *Compliance File No. CI 6208 and NPDES No. CA0057649* which will assure that the reports are directed to the appropriate file and staff.
